## **RESOLUTION NO. 431 series of 2022**

**A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE HON.  
GEORGE RICARDO R. GACULA II, TO ENTER INTO AND SIGN A  
MEMORANDUM OF AGREEMENT (MOA) WITH DAVIES PAINTS  
PHILIPPINES, INC., FOR THE REPAINTING OF SELECTED PEDESTRIAN  
OVERPASSES IN THE MUNICIPALITY OF TAYTAY, RIZAL**

WHEREAS, Section 16 and Section 17 of Republic Act No. 7160 otherwise known as the Local Government Code of 1991, expressly mandates Local Government Units to promote the general welfare of its inhabitants which includes the provision of facilities that would give comfort, enhance public health, safety and convenience to all the inhabitants of the Municipality;

WHEREAS, the Municipality of Taytay have numerous Pedestrian Overpasses / Footbridges built to lessen the road hazards / accidents at the major thoroughfare in the municipality;

WHEREAS, several of the constructed pedestrian overpasses / footbridges in the municipality needs maintenance and repainting due to its age and everyday usage;

WHEREAS, Davies Paints Philippines, Inc. offered to partner and cooperate with the Municipal Government of Taytay to repaint select pedestrian overpass in the municipality that needs maintenance and repainting, by submitting a proposed Memorandum of Agreement (MOA) to the Sanggunian;

WHEREAS, the 11<sup>th</sup> Sangguniang Bayan finds this endeavor worthy of legislation;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 11<sup>th</sup> Sangguniang Bayan of Taytay, Rizal, in session duly assembled, hereby AUTHORIZES THE LOCAL CHIEF EXECUTIVE HON. GEORGE RICARDO R. GACULA II, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT (MOA) WITH DAVIES PAINTS PHILIPPINES, INC., FOR THE REPAINTING OF SELECTED PEDESTRIAN OVERPASSES IN THE MUNICIPALITY OF TAYTAY, RIZAL.

RESOLVED FURTHER, that the painting of the logo and tagline of the Municipal Government of Taytay, Rizal to the selected pedestrian overpasses / footbridges shall be included in the premises of the MOA with Davies Paints Philippines, Inc.



RESOLVED FURTHERMOST, that the duly signed MOA shall be ratified first by the Sangguniang Bayan before its full implementation.


RESOLVED FINALLY, that copies of this Resolution be furnished and forwarded to all concerned for their information and appropriate action.
