R. GACULA II, IN BEHALF OF THE MUNICIPAL GOVERNMENT OF
TAYTAY, TO NEGOTIATE AND ENTER INTO AN AGREEMENT WITH JFRB
BUILDERS WHO WILL EXECUTE OR UNDERTAKE THE SOCIALIZED /
ECONOMIC HOUSING PROJECT FOR LOCAL GOVERNMENT EMPLOYEES
AND UNDERPRIVILEGED PERSON RESIDING IN TAYTAY, A PROPERTY
OWNED BY MR. HILARIO RESURRECCION LOCATED AT CABRERA
ROAD, HAPAY NA MANGGA, BRGY. DOLORES, TAYTAY, RIZAL**

WHEREAS, the Municipality of Taytay, through the leadership of the Mayor, Honorable George Ricardo R. Gacula II, would meet, discuss, and coordinate with agencies of the Local and National Government particularly the Pag-IBIG Fund, and Private Entities for the immediate realization of these housing projects;

WHEREAS, the Municipality of Taytay continues to give outmost priority, from among its programs, to the housing projects in order to provide decent and affordable housing to its constituents;

WHEREAS, individual and entities from the private sector are socially obligated to be aware and conscious of the state of welfare of communities they belong or conduct business with. It is worth considering that the welfare of these communities is also important to one's private business in the area as well;

WHEREAS, in line with the vision of the Local Government Unit to stimulate, assist, acquire home and provide shelter among Municipality of Taytay Employees by promoting homeownership through Socialized / Economic Housing Program;


NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 11th Sangguniang Bayan of Taytay, Rizal, in session duly assembled, hereby AUTHORIZES THE LOCAL CHIEF EXECUTIVE HON. GEORGE RICARDO R. GACULA II, IN BEHALF OF THE MUNICIPAL GOVERNMENT OF TAYTAY, TO NEGOTIATE AND ENTER INTO AN AGREEMENT WITH JFRB BUILDERS WHO WILL EXECUTE OR UNDERTAKE THE SOCIALIZED / ECONOMIC HOUSING PROJECT FOR LOCAL GOVERNMENT EMPLOYEES AND UNDERPRIVILEGED PERSON RESIDING IN TAYTAY, A PROPERTY OWNED BY MR. HILARIO RESURRECCION LOCATED AT CABRERA ROAD, HAPAY NA MANGGA, BRGY. DOLORES, TAYTAY, RIZAL.

RESOLVED FURTHER, that the signed Agreement shall be ratified first by the Sangguniang Bayan before its full implementation of the project.

RESOLVED FURTHERMORE, that copies of this Resolution be furnished early to all concerned for their information, guidance and appropriate action.
