## **RESOLUTION NO. 434 series of 2022**

### **A RESOLUTION EXPRESSING SUPPORT TO ALL PUBLIC ELEMENTARY AND HIGH SCHOOLS IN THE MUNICIPALITY OF TAYTAY TO PARTICIPATE IN THE IMPLEMENTATION OF LIMITED FACE-TO-FACE LEARNING MODALITY**

WHEREAS, given the President's approval of the recommendation for the progressive expansion of face-to-face classes, Education Secretary Leonor Magtolis Briones has authorized all regional directors to commence the progressive expansion phase of face-to-face classes for both public and private schools;

WHEREAS, Department of Education together with the Department of Health has issued Joint Memorandum No. 1 series of 2021 or the Operational Guidelines on the Implementation of Limited Face-to-Face Learning Modality dated September 27, 2021;

WHEREAS, Department of Education Issued Memorandum No. 71 series of 2021 or the Preparation for the Pilot Face-to-Face, Expansion and Transitioning to New Normal dated October 18, 2021;

WHEREAS, based under the Guidelines on the Nationwide Implementation of Alert Levels System for COVID-19 Response, limited face to face classes is now allowed under Alert Levels 1, 2 and 3, subject to certain conditions;

WHEREAS, to determine the level of readiness, All Public Elementary and High Schools in Taytay shall submit their School Safety Assessment Tool (SSAT) for validation to composite team from the School Division Office (SDO);

WHEREAS, item no. 6.1.4 of the DepEd, DOH Joint Memorandum No. 1 series of 2021 states that “The school shall have expressed support from LGUs (Barangay, Municipality, City, Province) in the form of a resolution or letter of support allowing them to participate in face-to-face classes”;

WHEREAS, each school shall prepare their own plans and policies for the operational framework of the implementation of the Face-to-Face Classes in coordination with the SDO and the LGU;

WHEREAS, Alternative Learning System (ALS) within Public Schools in the Municipality could be included in the implementation of the limited face-to-face learning modality provided that the same health protocols and safety measures be observed;


NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 11<sup>th</sup> Sangguniang Bayan of Taytay, Rizal, in session duly assembled, hereby EXPRESSES SUPPORT TO ALL PUBLIC ELEMENTARY AND HIGH SCHOOLS IN THE MUNICIPALITY OF TAYTAY TO PARTICIPATE IN THE IMPLEMENTATION OF LIMITED FACE-TO-FACE LEARNING MODALITY.

RESOLVED FURTHER, that a Letter of Support from the Office of the Mayor and a Certification from the Municipal Health Office shall be requested per school, provided that they have complied all requirements for the implementation of the limited face-to-face classes as stated under the Memorandum of the Department of Education.

RESOLVED FURTHERMORE, that copies of this Resolution be furnished to all concerned for their information and appropriate action.
