SPECIAL EDUCATION FUND (SEF) - CURRENT ACCOUNTS OF THE  
MUNICIPAL GOVERNMENT OF TAYTAY WITH PHILIPPINE VETERANS

WHEREAS, the Bureau of Local Government Finance (BLGF) Memorandum Circular No. 07-01-2017 enjoins compliance from Local Government Units to deposit government funds and maintain depository accounts with authorized government depository banks;

WHEREAS, the 11<sup>th</sup> Sangguniang Bayan passed Resolution No. 432 series of 2022: "A Resolution Authorizing the Local Chief Executive Hon. George Ricardo R. Gacula II, for the Closure of Depository Accounts of Taytay Municipal Government in Philippine National Bank



(PNB), Taytay Branch and to initially open Depository Accounts in Philippine Veterans Bank and Landbank of the Philippines, both Taytay Branch, for Special Education Fund (SEF) and other Depository Accounts of this Municipality”, in compliance to the BLGF Memorandum Circular No. 07-01-2017;

WHEREAS, the newly opened Philippine Veterans Bank Taytay Branch, is an authorized government depository banks listed in the same BLGF Memorandum Circular wherein this Municipal Government can have a convenient access in opening a depository accounts for its SEF Fund and other accounts;

WHEREAS, the Sangguniang Bayan has been requested to pass a resolution authorizing Ms. Joyce D. Yoingco, Municipal Administrator and Ms. Melinda V. Reyes, Acting Municipal Treasurer as additional signatories for the opening of Special Education Fund (SEF) – Current Account of the Municipal Government of Taytay with Philippine Veterans Bank Taytay Branch;


