RESOLUTION NO. 443 series of 2022

A RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HON. GEORGE RICARDO R. GACULA II, TO ENTER INTO A MEMORANDUM OF UNDERSTANDING (MOU) WITH THE LAGUNA LAKE DEVELOPMENT AUTHORITY (LLDA), FOR THE IMPLEMENTATION OF THE LLDA PROJECT: "INTRODUCTION OF NUTRIENT LIMITING MECHANISM TO PREVENT ALGAL BLOOM IN LAGUNA LAKE"

WHEREAS, Section 16 General Welfare Clause of RA 7160 also known as the Local Government Code of 1991, provides in part that: "every local government unit shall exercise the powers expressly granted, those necessarily implied there from, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare. Within their respective territorial jurisdictions, local government units shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, enhance the right of the people to a balanced ecology,...";

WHEREAS, the Laguna Lake Development Authority (LLDA) is mandated "to promote and accelerate the development and balanced growth of the Laguna Lake area and the surrounding provinces, cities and towns within the region, in the context of the national and regional plans and



policies for social and economic development and to carry out the development of the Laguna Lake region with due regard and adequate provisions for environmental management and control, preservation of the quality of human life and ecological systems, and the prevention of undue ecological disturbances, deterioration and pollution";

WHEREAS, the Municipal Government of Taytay recognizes the value of uniting and working together with LLDA to provide a clean, healthy and safe environment, thereby supports the environmental improvement of the Laguna Lake;

WHEREAS, the Sangguniang Bayan received a letter from the Office of the Municipal Environment and Natural Resources requesting for a Resolution Authorizing the Mayor, Hon. George Ricardo R. Gacula II, to enter into a Memorandum of Understanding with LLDA with regards to the implementation of the LLDA project known as "Introduction of Nutrient Limiting Mechanism to Prevent Algal Bloom in Laguna Lake";

WHEREAS, the Sangguniang Bayan finds the endeavor worth legislating as it will greatly benefit the constituents of Taytay particularly the fisher folks;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 11th Sangguniang Bayan of Taytay, Rizal, in session duly assembled, hereby AUTHORIZES THE MUNICIPAL MAYOR, HON. GEORGE RICARDO R. GACULA II, TO ENTER INTO A MEMORANDUM OF UNDERSTANDING (MOU) WITH THE LAGUNA LAKE DEVELOPMENT AUTHORITY (LLDA), FOR THE IMPLEMENTATION OF THE LLDA PROJECT: "INTRODUCTION OF NUTRIENT LIMITING MECHANISM TO PREVENT ALGAL BLOOM IN LAGUNA LAKE".

RESOLVED FURTHER, that the duly signed Memorandum of Understanding (MOU) with LLDA shall be ratified first by the Sangguniang Bayan before its implementation.

RESOLVED FURTHERMORE, that the copy of this Resolution be furnished to all concerned for their information and appropriate action.
