**A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE HON.
GEORGE RICARDO R. GACULA II, TO ENTER INTO AND SIGN A
CONTRACT OF LEASE WITH DITO TELECOMMUNITY CORPORATION,
FOR THE CONSTRUCTION, INSTALLATION AND OPERATION OF FOUR (4)
MICRO – CELLSITE OR POLE CELLSITE AT LUPANG ARENDA, BRGY.
STA. ANA, TAYTAY, RIZAL**

WHEREAS, every Local Government Unit is encouraged to support the development of appropriate, self-reliant, scientific and technological capacities to enhance economic prosperity as provided in the General Welfare clause of RA 7160 also known as the Local Government Code of the Philippines;

WHEREAS, DITO Telecommunity Corporation, a corporation duly organized and existing under the laws of the Republic of the Philippines and formerly known as Mislattel or Mindanao Islamic Telephone Company, Inc. has been named as the third major telecommunications provider in the Philippines;

WHEREAS, DITO Telecommunity Corporation as the newest telecommunications provider, is undergoing a nationwide rollout of network to be able to provide a better and faster services to future subscribers, thus has the intention to construct, install and operate four (4) Micro Cellsite or Pole Cellsite at Lupang Arenda, Brgy. Sta. Ana, Taytay, Rizal;

WHEREAS, the Sangguniang Bayan previously passed a Resolution authorizing the Local Chief Executive to enter and sign a Contract of Lease with DITO Telecommunity Corporation for the construction / installation of a cell site tower at Purok 8 Bagong Pag-asa, Brgy Sta. Ana, however, there are pending projects of the national government that will traverse the Lupang Arenda which incidentally include the previously approved cell site tower location, thus the need for the new location;

WHEREAS, the proposed location of the four (4) Micro Cellsite or Pole Cellsite are the following: Purok 7 (Barangay Outpost) Lupang Arenda, Brgy. Sta. Ana, Purok 6 (Barangay Outpost) Lupang Arenda, Brgy. Sta. Ana, Purok 4 Lupang Arenda, Brgy. Sta. Ana, and Barangay Hall Lupang Arenda, Brgy. Sta. Ana;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved by the 11th Sangguniang Bayan of Taytay, Rizal, in session duly assembled, hereby AUTHORIZES THE LOCAL CHIEF EXECUTIVE HON. GEORGE RICARDO R. GACULA II, TO ENTER INTO AND SIGN A CONTRACT OF LEASE WITH DITO TELECOMMUNITY CORPORATION, FOR THE CONSTRUCTION, INSTALLATION AND OPERATION OF FOUR (4) MICRO – CELLSITE OR POLE CELLSITE AT LUPANG ARENDA, BRGY. STA. ANA, TAYTAY, RIZAL.


RESOLVED FURTHER, that the duly signed Contract of Lease shall be ratified first by the Sangguniang Bayan before its implementation.

RESOLVED FURTHERMORE, that DITO Telecommunity Corporation must secure the necessary permits before the construction / installation of the cell site tower.
