RESOLUTION NO. 445 series of 2022

A RESOLUTION ADOPTING REPUBLIC ACT NO. 11261 OTHERWISE KNOWN AS THE "FIRST TIME JOBBEEKERS ASSISTANCE ACT" IN THE MUNICIPALITY OF TAYTAY, RIZAL

WHEREAS, Republic Act No. 11261 entitled: "An Act waiving Government Fees and Charges in the issuance of Documents Required in the Application for Employment of First Time Jobseekers", was passed by the Senate of the Philippines and the House of Representatives on February 6, 2019 and approved by the President on April 10, 2019;

WHEREAS, as stated in the Republic Act, it is the policy of the State to promote full employment and equality of gainful work and opportunities for its citizens. As such, the State shall expand accessibility to government services and provide incentives to improve first time jobseeker's access to employment;

WHEREAS, it is a declared policy of the Municipality of Taytay to promote the welfare of its constituents thru employment programs that aim to generate jobs for the qualified work force from Taytay;



NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 11th Sangguniang Bayan of Taytay, Rizal, in session duly assembled, hereby ADOPTS REPUBLIC ACT NO. 11261 OTHERWISE KNOWN AS THE "FIRST TIME JOBBEEKERS ASSISTANCE ACT" IN THE MUNICIPALITY OF TAYTAY, RIZAL.
