A RESOLUTION SUPPORTING THE REQUEST OF ALLIANCE OF PEOPLE'S ORGANIZATION IN LUPANG ARENDA (APOLA) TO THE DEPARTMENT OF HUMAN SETTLEMENTS AND URBAN DEVELOPMENT (DHSUD) TO FUND THE CONSTRUCTION OF TWO (2) COVERED COURTS IN LUPANG ARENDA, MUNICIPALITY OF TAYTAY, RIZAL

WHEREAS, the Sangguniang Bayan have passed Resolution No. 195 declaring Lupang Arenda habitable and suitable for socialized housing program / project based on the findings and recommendations of the local technical working group for Lupang Arenda (LTWG) of this Municipality;

WHEREAS, on March 8, 2022, the Sangguniang Bayan received the request of Alliance of People's Organization in Lupang Arenda (APOLA) for the construction of two (2) covered courts in unoccupied lots at ABNAI Purok 1 and AKBAI area Purok 5 using the Socialized Balanced Housing Fund of the Department of Human Settlements and Urban Development (DHSUD);

WHEREAS, the Municipality of Taytay recognizes the importance of physical fitness and exercise during and after the COVID-19 Pandemic and the realities that this pandemic has made it difficult for its constituents in Lupang Arenda to adequately maintain their normal physical activity patterns;

WHEREAS, the Municipality of Taytay recognizes that this significant decline in physical activities and exercise patterns have ill effects on the physical and mental health statuses of its constituents;

WHEREAS, the Municipality of Taytay, for the benefit of its constituents' physical and mental health, finds no opposition to and supports the construction of these two (2) covered courts to combat the decline in their physical activities and exercise patterns;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 11th Sangguniang Bayan of Taytay, Rizal, in session duly assembled, hereby SUPPORTS THE REQUEST OF ALLIANCE OF PEOPLE'S ORGANIZATION IN LUPANG ARENDA (APOLA) TO THE DEPARTMENT OF HUMAN SETTLEMENTS AND URBAN DEVELOPMENT (DHSUD) TO FUND THE CONSTRUCTION OF TWO (2) COVERED COURTS IN LUPANG ARENDA, MUNICIPALITY OF TAYTAY, RIZAL.
