A RESOLUTION ENDORSING TO THE OFFICE OF THE PRESIDENT, HIS EXCELLENCY RODRIGO ROA DUTERTE THROUGH THE DEPARTMENT OF BUDGET AND MANAGEMENT (DBM) OFFICER-IN-CHARGE MS. TINA ROSE MARIE L. CANDA, THE PROJECT "ASSISTANCE TO INDIGENT INDIVIDUAL (INDIVIDUAL IN CRISIS)" OF THE MUNICIPALITY OF TAYTAY, RIZAL, FOR FUNDING THRU THE LOCAL GOVERNMENT SUPPORT FUND - FINANCIAL ASSISTANCE TO LOCAL GOVERNMENT UNITS (FY 2022 LGSF - FALGU) IN THE AMOUNT OF TEN MILLION PESOS (PHP 10,000,000.00)

WHEREAS, Section 16 of the General Welfare Clause of RA 7160 provides in part that "every local government unit shall exercise powers necessary for its efficient and effective governance and those which are essential to the promotion of the general welfare";

WHEREAS, the Project "Assistance to Indigent Individuals (Individuals in Crisis)" is part of the duly adopted Local Development Investment Program (LDIP) as well as the Annual Investment Program (AIP) for FY 2022 of this Municipality;





WHEREAS, the said Project is aligned with the President's Proclamation No. 1218 Extending the Period of the State of Calamity throughout the Philippines due to COVID-19 until September 12, 2022 unless lifted or extended as the circumstances may warrant;

WHEREAS, the project herein listed is among the allowable projects for funding under LGSF 2022 as guided by DBM Circular No. 142 dated January 24, 2022;

WHEREAS, the Local Chief Executive, Hon. Mayor George Ricardo R. Gacula II wrote a letter to the Office of the President, Hon. Rodrigo Roa Duterte requesting for an allocation of Ten Million Pesos (Php 10,000,000.00) as assistance in the form of additional funding for medicines for COVID-19 response and the municipality is fortunate that they heeded our call to action;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved by the 11<sup>th</sup> Sangguniang Bayan of Taytay, Rizal, in session duly assembled, hereby ENDORSES TO THE OFFICE OF THE PRESIDENT, HIS EXCELLENCY RODRIGO ROA DUTERTE THROUGH THE DEPARTMENT OF BUDGET AND MANAGEMENT (DBM) OFFICER-IN-CHARGE MS.
