## RESOLUTION NO. 455 series of 2022



DUAVIT, RIZAL FIRST DISTRICT REPRESENTATIVE, TO GRANT FINANCIAL ASSISTANCE TO FIRE VICTIMS WHOSE HOUSES WERE TOTALLY DAMAGED BY THE FIRE INCIDENT THAT OCCURRED LAST MAY 15, 2022 AT #49 NATIONAL ROAD, BARANGAY MUZON, TAYTAY, RIZAL

WHEREAS, last May 15, 2022, a fire broke out at #49 National Road, Barangay Muzon, this Municipality;
