WHEREAS, the Local Government of Taytay, Rizal have constructed multi-purpose halls and covered courts within the municipality for the benefit of its constituents;

WHEREAS, said multi-purpose halls and covered courts are also managed and maintained by the local government;

WHEREAS, several homeowners association in Lupang Arenda, Brgy. Sta. Ana, Taytay, Rizal, wishes that the management of the multi-purpose halls and covered courts in their area be turned over to their association for better management and easier access;

5. Multi-Purpose Building / SILAHOA Office at Blk. 17 Purok 2, Lupang Arenda
6. Multi-Purpose Building / Office of PACHOA at Blk. 27 Purok 5, Lupang Arenda
7. Multi-Purpose Office of AKBALHOA at Blk. 22 Purok 5, Lupang Arenda
8. Multi-Purpose Office of Bay Garden Homes at Blk. 3 Purok 3, Lupang Arenda

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved by the 11th Sangguniang Bayan of Taytay, Rizal, in session duly assembled, hereby AUTHORIZES THE MAYOR HON. GEORGE RICARDO R. 
