## **RESOLUTION NO. 459 series of 2022**

### **A RESOLUTION RATIFYING THE MEMORANDUM OF UNDERSTANDING BY AND BETWEEN THE MUNICIPAL GOVERNMENT OF TAYTAY AND JFRB BUILDERS FOR THE SOCIALIZED AND ECONOMIC HOUSING PROJECT FOR THE MUNICIPALITY OF TAYTAY EMPLOYEES AND RESIDENTS**

WHEREAS, the 11<sup>th</sup> Sangguniang Bayan passed Resolution No. 433 series of 2022 entitled: "Authorizing the Local Chief Executive Hon. George Ricardo R. Gacula II, in behalf of the Municipal Government of Taytay, to negotiate and enter into an Agreement with JFRB Builders who will execute or undertake the Socialized / Economic Housing Project for Local Government Employees and Underprivileged Person residing in Taytay, a property owned by Mr. Hilario Resurreccion located at Cabrera Road, Hapay na Mangga, Brgy. Dolores, Taytay, Rizal";


