POSITION WHO HAVE SHOWN EFFICIENCY, COMPETENCE AND  
INTEGRITY IN THE PERFORMANCE OF THEIR WORK AND WHO  
HAVE BEEN APOLITICAL IN THE LAST ELECTION PERIOD**

WHEREAS, there is lingering apprehension among employees whether regular, casual or job order regarding the status of their employment or their assignment to different offices in the municipality;

WHEREAS, some of these employees have been performing their functions efficiently and have gained a semblance of expertise or knowledge in the task assigned to them;

WHEREAS, these employees were also apolitical during the last campaign and election period and chose to abide by the rules and regulations provided by civil service commission about the conduct of government employees during the election period;

WHEREAS, among the platform and campaign propaganda of Hon. Mayor-Elect Allan Martine S. De Leon during the election is to foster unity and respect and avoid a vengeful administration against those who have contrary opinion;


WHEREAS, retaining the above-mentioned employees in their respective position will ensure continuity in the delivery of services, avoid the training of new personnel, and is in accordance with the policy of providing security of tenure;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved by the 11<sup>th</sup> Sangguniang Bayan of Taytay, Rizal, in session duly assembled, hereby REQUESTS HON. MAYOR-ELECT ALLAN MARTINE S.
