**APPROVING AND RATIFYING THE MDC – EXECUTIVE COMMITTEE
RESOLUTION NO. 2022 – 001 ENTITLED: “A RESOLUTION AMENDING
(ADDENDUM) THE ANNUAL INVESTMENT PROGRAM (AIP) CY 2022”**

WHEREAS, Section 16 of the General Welfare Clause of RA 7160 provides in part that every local government unit shall exercise powers necessary for its efficient and effective governance and those which are essential to the promotion of the general welfare;

WHEREAS, last September 7, 2021, the Sangguniang Bayan had approved and ratified the Annual Investment Program (AIP) FY 2022 of the Municipality of Taytay, Rizal through SB Resolution No. 369 series of 2021;

WHEREAS, last December 14, 2021, the Sangguniang Bayan had approved and ratified the Addendum to the Annual Investment Program (AIP) CY 2022 to add the various priority

projects / programs / activities for the Municipality of Taytay, Rizal amounting to Four Hundred Forty-One Million Six Hundred Sixty-Five Thousand Four Hundred Eighty-Six Pesos and Two Centavos (Php 441,665,486.02) through SB Resolution No. 407 series of 2021;

WHEREAS, the projects / programs / activities listed above will greatly help to augment the fund deficiencies to provide better services to its constituents and to achieve the municipality's development goals;


WHEREAS, submitted to the Honorable August Body is MDC – Executive Committee Resolution No. 2022 – 001 for approval and ratification;
