**APPROVING AND RATIFYING THE MDC – EXECUTIVE COMMITTEE
RESOLUTION NO. 2022 – 002 ENTITLED: “A RESOLUTION REVERSING
THE FUNDS FROM UNAPPROPRIATED BALANCE, RETAINED
EARNINGS FY 2021 TO APPROPRIATE TO VARIOUS PROJECTS /
PROGRAMS FOR THE 20% DEVELOPMENT FUND FOR THE
MUNICIPALITY”**

WHEREAS, Section 16 of the General Welfare Clause of RA 7160 provides in part that every local government unit shall exercise powers necessary for its efficient and effective governance and those which are essential to the promotion of the general welfare;

WHEREAS, there is an amount of Two Million Six Hundred Ninety-Five Thousand Three Hundred Twenty-Two Pesos and Twenty-Six Centavos (Php 2,695,322.26) from the Unappropriated Balance, Retained Earnings FY 2021;

WHEREAS, the Municipal Development Council finds the reversion of funds from the Unappropriated Balance, Retained Earnings FY 2021 necessary in order to utilize the subject funds;

WHEREAS, the reverted funds shall be used to appropriate the following priority projects / programs for the municipality under the 20% Development Fund FY 2022, to wit:
