RESOLUTION INTERPOSING NO OBJECTION TO THE REQUEST OF SPS. LILIAN CARREON AND LEONARDO CARREON FOR THE CONVERSION OR RECLASSIFICATION OF PORTIONS OF PARCEL OF LAND COVERED BY TCT NO. 551103 SITUATED IN BRGY. SAN JUAN, TAYTAY, RIZAL FROM ROAD LOT TO RESIDENTIAL LOT

WHEREAS, the Sangguniang Bayan received a letter from Sps. Lilian Carreon and Leonardo Carreon requesting for the conversion or reclassification of portions of Parcel of Land covered by TCT No. 551103 situated in Barangay San Juan, Taytay, Rizal from Road Lot to Residential Lot;

WHEREAS, the Chairman on the Committee on Housing and Land Utilization wrote a letter to the Municipal Assessor and the Municipal Planning and Development Officer seeking recommendation on the pertaining to the request letter, based on the Rules and Regulations mandated by their Office;

WHEREAS, based on the records from the Assessor Office and the Municipal Planning Development Office, the subject property being requested for conversion or reclassification is identified as lot 3-C-2-C-7, Psd-04-023448 with TCT No. 551103, containing an area of 660



square meters, registered under the name of Lilian I. Carreon, covered by Tax Declaration No. 18-TY-004-16880, and classified as Road Lot;


