WHEREAS, the Committee on Rules, Resolutions and Ordinances reviewed the aforementioned statute to check on the merits of the pronouncement from the Barangay's Local Government Unit;

WHEREAS, after a thorough discussion and deliberation, it was agreed upon by the Committee members to approve the said declaration as within the scope and powers of the Sangguniang Barangay as prescribed in the adopted Committee Report of the Committee on Rules, Resolutions and Ordinances;

RESOLVED FURTHER, that copies of this Resolution be furnished to all concerned for their information and appropriate action.


