WHEREAS, the Sangguniang Barangay Secretariat of Barangay Dolores submitted to the Sangguniang Bayan for review the following:

- EXECUTIVE ORDER NO. 4: An Order Reorganizing the Barangay Anti-Drug Abuse Council (BADAC) Referral Desk Officers dated August 5, 2022
- EXECUTIVE ORDER NO. 5: An Executive Order Reconstituting the Bids and Awards Committee (BAC) and BAC Secretariat of Barangay Dolores, Taytay, Rizal dated August 26, 2022
- EXECUTIVE ORDER NO. 6: An Executive Order Designating Barangay Safety Officer dated August 26, 2022
- EXECUTIVE ORDER NO. 7: An Executive Order Designating the VAW Desk Person as the Anti-Sexual Harassment (ASH) Desk Officer for Barangay dated August 26, 2022
- EXECUTIVE ORDER NO. 8: An Order Reorganizing the Barangay Development Council (BDC) of Barangay Dolores, Taytay, Rizal dated September 5, 2022

- EXECUTIVE ORDER NO. 9: An Order Reorganizing the Barangay Disaster Risk Reduction Management Committee (BDRRMC) of Barangay Dolores, Taytay, Rizal dated September 5, 2022
- EXECUTIVE ORDER NO. 10: An Order Reorganizing the Barangay Anti-Drug Abuse Council (BADAC) of Barangay Dolores dated September 5, 2022


RESOLVED FURTHER, that copies of this Resolution be furnished to all concerned for their information and appropriate action.
