WHEREAS, Ordinance No. 2, s. 2022, enacted by the Sangguniang Barangay of Barangay San Juan in this Municipality has appropriated the amount of One Hundred Forty-Two Million Two Hundred Seventy-Three Thousand Five Hundred Twenty-Two Pesos (Php 142,273,522.00) as its Annual Budget for FY 2023;

WHEREAS, the review of the Barangay Budget was expressly lodged to the Sangguniang Bayan conformably with Section 333 of R.A. 7160;

WHEREAS, the Annual Budget of Barangay San Juan FY 2023 as submitted was initially reviewed and evaluated by the Municipal Budget Officer and have recommended that it be declared operative subject to conditions set forth in the review letter hereto attached;

WHEREAS, upon further review, the Sangguniang Barangay of Barangay San Juan have complied with the budgetary requirements and general limitations provided in the Local Government Code; Budget does not exceed the estimated receipts or income of the Barangay; and the items for appropriation are not more than those provided by existing laws;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 12th Sangguniang Bayan of Taytay, Rizal, in session duly assembled, hereby APPROVES IN REVIEW AND DECLARES THE ANNUAL BUDGET OF BARANGAY SAN JUAN FY 2023 IN THE AMOUNT OF ONE HUNDRED FORTY-TWO MILLION TWO HUNDRED SEVENTY-THREE THOUSAND FIVE HUNDRED TWENTY-TWO PESOS (PHP 142,273,522.00) UNDER SANGGUNIANG BARANGAY APPROPRIATION ORDINANCE NO. 2, S. 2022, OPERATIVE SUBJECT TO CONDITIONS.

RESOLVED FURTHER, that Sangguniang Barangay of Barangay San Juan shall strictly comply with the conditions set forth in the review and recommendation letter dated February 2, 2023 of the Municipal Budget Officer which shall form an integral part of this Resolution.

RESOLVED FURTHERMORE, that the SK Fund form part of the Barangay San Juan Annual Appropriation Ordinance.

RESOLVED FINALLY, that copies of this Resolution be furnished to all concerned for their information and appropriate action.
