WHEREAS, Section 16 of the General Welfare Clause of RA 7160 provides in part that every local government unit shall exercise powers necessary for its efficient and effective governance and those which are essential to the promotion of the general welfare;

WHEREAS, submitted to the Honorable August Body is TDC Resolution No. 2023 – 001: “A Resolution Recommending Approval to the Amendment of TDC Resolution No. 2022 – 002”, for approval and ratification of the Sanggunian;

WHEREAS, last November 16, 2022 the Sangguniang Bayan approved and ratified TDC Resolution No. 2022 – 002 entitled: “A Resolution Recommending Approval of the Re-Alignment of Funds from PPAs under the 20% Development Fund Amounting to Thirty Million Five Hundred Fifty-Nine Thousand Twelve Pesos and Eighty-Nine Centavos (P 30,559,012.89) to Various Priority Projects / Programs / Activities of the Municipality”, by virtue of Sangguniang Bayan Resolution No. 120 s. 2022;

WHEREAS, TDC Resolution No. 2022 – 002 was amended because a project entitled: “Concrete Overlay of Road at Madlanghaya St. / Proposed Concrete Overlay of Road with CHB Lining at Madlanghaya – Buenmar St., Brgy. San Juan” was not implemented but has been obligated;

WHEREAS, said project in the TDC Resolution No. 2022 – 002 will be replaced with a project entitled: “Proposed Construction of Mushroom Production Facility” with a project cost of Two Million Pesos (P 2,000,000.00);

WHEREAS, listed below are the projects / programs / activities as amended, amounting to Thirty Million Four Hundred Ninety-Five Thousand Six Hundred Twenty-Six Pesos and Ninety-

One Centavos (P 30,495,626.91) for realignment and the programs / projects to which said amount will be allocated, to wit:


