A RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, ALLAN MARTINE S. DE LEON, MPA, TO SIGN AND ENTER INTO A MEMORANDUM OF AGREEMENT WITH PHILIPPINE VETERANS BANK TO OPEN AND MAINTAIN DEPOSIT AND/OR TRUST ACCOUNTS AND INSTALL AN OFF-SITE ATM UNIT FOR THE USE OF TAYTAYEÑO CONSTITUENTS, AND FOR OTHER PURPOSES

WHEREAS, Section 3, Article XIII of the 1987 Constitution provides that the State shall, "[i]nclude the commitment to create economic opportunities based on freedom of initiative and self-reliance";

WHEREAS, Section 16 of Republic Act ("R.A.") No. 7160, otherwise known as the Local Government Code states that, "[e]very local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare";

WHEREAS, Section 444(b)(1)(vi) of R.A. No. 7160, provides that the Municipal Mayor, upon authorization by the Sangguniang Bayan, may represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinance;

WHEREAS, Section 3(h) of R.A. No. 10844, provides that the State shall "[p]romote the use of ICT for the enhancement of key public services, such as education, public health and safety, revenue generation, and socio-civic purposes";

WHEREAS, the Philippine Veterans Bank ("PVB") represents itself as a private commercial bank duly created and authorized to accept deposits from government entities and instrumentalities pursuant to R.A. No. 3518, as amended by R.A. No. 7169 and 11597, and offers its banking services and facilities to the Local Government Unit ("LGU");

WHEREAS, the LGU has decided to utilize the banking services and facilities offered by the PVB and for this purpose, open and maintain current / savings and various deposit accounts with PVB together with the installation of an off-site ATM unit within the municipality premises for the use of employees and its constituents;

WHEREAS, consistent with the goal of providing *Serbisyong May Ngiti* to all Taytayeños, the signing of said contract will strengthen the mission of this Municipality to preserve the comfort and convenience of all its inhabitants through providing fast and enhanced delivery of public service;



NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 12<sup>th</sup> Sangguniang Bayan of Taytay, Rizal, in session duly assembled, to AUTHORIZE THE MUNICIPAL MAYOR, ALLAN MARTINE S. DE LEON, MPA, TO SIGN AND ENTER INTO A MEMORANDUM OF AGREEMENT WITH PHILIPPINE VETERANS BANK TO OPEN AND MAINTAIN DEPOSIT AND/OR TRUST ACCOUNTS AND INSTALL AN OFF-SITE ATM UNIT FOR THE USE OF TAYTAYEÑO CONSTITUENTS, AND FOR OTHER PURPOSES.

RESOLVED FINALLY, that a copy of this Resolution shall be forwarded to the Office of the Municipal Mayor and all concerned Offices in the Municipal Government of Taytay.
