WHEREAS, the Municipal Mayor issued Executive Order No. 62, series of 2023 signed last March 01, 2023, establishing the policy requiring all motorcycle riders and back riders to remove their helmets while traversing municipal and barangay roads within the municipality;

WHEREAS, Republic Act No. 10054 or the Motorcycle Helmet Act of 2009, provides under Section 3, that "[a]ll motorcycle riders, including drivers and back riders, shall at all times wear standard protective motorcycle helmets while driving, whether long or short drives, in any type of road and highway";

WHEREAS, this August Body believes that while it is important to provide means to eliminate the cases of riding-in-tandems, it is also imperative that we do not compromise the safety of the general motorcycle riders;

WHEREAS, the Sangguniang Bayan enjoins the Executive Department in providing mechanisms to eliminate the cases of riding-in-tandem and would support any executive decision that will both lessen incidences of crime in the municipality and promote overall public safety;

WHEREAS, the Sangguniang Bayan believes that further review of the Executive Order and the conduct of additional public consultations will help shape this policy better all for the betterment of our community;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 12th Sangguniang Bayan of Taytay, Rizal, in session duly assembled, to HUMBLY REQUEST HON. MAYOR ALLAN MARTINE S. DE LEON, MPA, TO RETRACT AND FURTHER REVIEW THE ISSUANCE OF EXECUTIVE ORDER NO. 62 SERIES OF 2023 ON THE REMOVAL OF HELMETS IN MUNICIPAL AND BARANGAY ROADS WITHIN THE MUNICIPALITY.

RESOLVED FURTHER, that a copy of this Resolution shall be forwarded to the Office of the Municipal Mayor and all concerned Offices in the Municipal Government of Taytay.
