WHEREAS, the Municipality of Taytay, Rizal does not have sufficient funds to finance the construction of the hospital which is estimated to be at least One Billion Pesos (P1,000,000,000.00) including its equipment;

WHEREAS, the National Government, through the Speaker of the House of Representative may be able to support the Municipality of Taytay, Rizal in its effort to construct the said general hospital;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 12th Sangguniang Bayan of Taytay, Rizal, in session duly assembled, to REQUEST THE HON. SPEAKER FERDINAND MARTIN G. ROMUALDEZ TO CONSIDER FUNDING THE CONSTRUCTION OF A GENERAL HOSPITAL IN TAYTAY, RIZAL.
