**A RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, ALLAN MARTINE S. DE LEON, MPA, TO REPRESENT AND SIGN FOR THE MUNICIPAL GOVERNMENT IN THE MEMORANDUM OF AGREEMENT WITH THE PHILIPPINE STATISTICS AUTHORITY FOR THE PHILSYS BIRTH REGISTRATION ASSISTANCE PROJECT**

WHEREAS, the Philippine Statistics Authority (“PSA”), under R.A. No. 10625, otherwise known as the Philippine Statistical Act of 2013, was mandated to collect, compile, analyze, abstract, and publish statistical information relating to the Philippines’s economic, social, demographical, political, and general activities, and the general condition of the Filipino people;

WHEREAS, under Rule 11 Article (c) of the Implementing Rules and Regulations (“IRR”) of R.A. No. 10625, the National Statistician, who is also serving as the Civil Registrar General, is required to provide overall direction in the implementation of the Civil Registry Law and all related issuances, and is tasked to exercise technical supervision over all civil registrars;

WHEREAS, the PSA is implementing a project entitled: “PhilSys Birth Registration Assistance Project (“PBRAP”) for the Province of Rizal”, aiming to increase civil registration in marginalized communities, particularly those belonging to Indigenous Peoples, Muslim Filipinos, and the poorest sector;

WHEREAS, the PSA, in collaboration with the Department of the Interior and Local Government (“DILG”) and the Municipal Government of Taytay, all aim to register the unregistered births aligned with the creation of a single identity card for all Filipinos, pursuant to R.A. No. 11055, otherwise known as the Philippine Identification System Act;

WHEREAS, the goals of PSA, in coordination with the DILG, is aligned with the intent of the Municipal Government of Taytay to provide utmost *Serbisyong May Ngiti* to all Taytayeyños by centralizing registration and ensuring that all Taytayeyño constituents will be properly registered and identified in order to receive government assistance and service;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 12<sup>th</sup> Sangguniang Bayan of Taytay, Rizal, in session duly assembled, to AUTHORIZE THE MUNICIPAL MAYOR, ALLAN MARTINE S. DE LEON, MPA, TO REPRESENT AND SIGN FOR THE MUNICIPAL GOVERNMENT IN THE MEMORANDUM OF AGREEMENT WITH THE PHILIPPINE STATISTICS AUTHORITY FOR THE PHILSYS BIRTH REGISTRATION ASSISTANCE PROJECT.

RESOLVED FINALLY, that a copy of this Resolution shall be forwarded to the Office of the Municipal Mayor, and all concerned offices in the Municipal Government of Taytay.


