A RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, ALLAN MARTINE S. DE LEON, MPA, TO REPRESENT AND SIGN FOR THE MUNICIPAL GOVERNMENT IN THE MEMORANDUM OF AGREEMENT WITH THE MANILA ELECTRIC COMPANY FOR THE ELECTRONIC CERTIFICATE OF FINAL ELECTRIC INSPECTION ISSUANCE

WHEREAS, Section 444(b)(1)(vi) of Republic Act ("R.A.") No. 7160, otherwise known as the Local Government Code of 1991, provides that the Municipal Mayor, upon authorization by the Sangguniang Bayan, may represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinance;

WHEREAS, Section 444(2) of R.A. No. 7160 provides that the Municipal Mayor shall enforce all laws and ordinances relative to the governance of the municipality and the exercise of its corporate powers, and implement all approved policies, programs, projects, services and activities of the municipality;

WHEREAS, Section 444(5) of R.A. No. 7160 provides that the Municipal Mayor shall exercise such other powers and perform such other duties and functions as may be prescribed by law or ordinance;

WHEREAS, the Manila Electric Company ("MERALCO") is a private electric distribution company operating in the Province of Rizal by virtue of R.A. NO. 9209;

WHEREAS, in order for MERALCO to connect electricity to Taytayeño constituents, the Municipal Government, through the Municipal Engineering Office, must first issue a Certificate of Final Electrical Inspection ("CFEI") or the Permit for Temporary Service Connection ("Temporary Permit") in favor of the applicant;

WHEREAS, to streamline the issuance of CFEIs and Temporary Permits by the Municipal Government in coordination with the MERALCO, a Memorandum of Agreement ("MOA") is required to be signed between the parties;

WHEREAS, the signing of the MOA with MERALCO is aligned with the intent of the Municipal Government of Taytay to provide utmost *Serbisyong May Ngiti* to all Taytayefios by streamlining processes in the Municipal Government pursuant to the principles of R.A. No. 11032, otherwise known as the Ease of Doing Business and Efficient Government Service Delivery Act of 2018;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 12th Sangguniang Bayan of Taytay, Rizal, in session duly assembled, to AUTHORIZE THE MUNICIPAL MAYOR, ALLAN MARTINE S. DE LEON, MPA, TO REPRESENT AND SIGN FOR THE MUNICIPAL GOVERNMENT IN THE MEMORANDUM OF AGREEMENT WITH THE MANILA ELECTRIC COMPANY FOR THE ELECTRONIC CERTIFICATE OF FINAL ELECTRIC INSPECTION ISSUANCE.

RESOLVED FINALLY, that a copy of this Resolution shall be forwarded to the Office of the Municipal Mayor, and all concerned offices in the Municipal Government of Taytay.
