**A RESOLUTION HUMBLY REQUESTING THE LOCAL CHIEF EXECUTIVE  
MAYOR ALLAN MARTINE S. DE LEON, MPA, TO CONDUCT AN  
INVESTIGATION AND TO CREATE A TASK FORCE TO TAKE  
APPROPRIATE ACTION ON THE GROWING NUMBER OF INFORMAL  
SETTLERS ALONG THE AREA OF THE LAGUNA LAKE IN THE  
MUNICIPALITY OF TAYTAY**

WHEREAS, the Department of the Interior and Local Government (DILG) issued Memorandum Circular 2011-17 tasking the Local Chief Executives to devise mechanisms for the prevention of the proliferation of informal settlers in their respective local government units;

WHEREAS, there is a growing number of informal settlers, sprouting in the areas alongside the Laguna Lake, constructing homes and road networks;

WHEREAS, some of these informal settlers are already encroaching in private properties and in some of the farming areas of registered farming groups in the municipality;

WHEREAS, to maintain peace and order, promote public safety, and to protect the human rights of every individual, the municipal government should act on this matter and extend any possible support in ensuring peaceful communication and coordination with the existing households located in the area;

WHEREAS, a Task Force may be formed to conduct a thorough investigation on the matter and to recommend action and steps to prevent the further growth of informal settlers in the aforementioned area;

WHEREAS, the Task Force may be composed of representatives from the Municipal Assessors Office, Municipal Planning and Development Office, Municipal Environment and Natural Resources Office, Municipal Agriculture Office, Municipal Legal Office, Urban Poor Affairs Office and the Committee Chairpersons for Housing, Land Utilization and Urban Planning, and Agriculture, Fisheries and Aquatic Resources;

WHEREAS, this August Body believes that controlling illegal housing and development in the area of the lake is to the best interest of the people in consideration of their safety and living conditions;

WHEREAS, the Local Government Unit of Taytay commits itself in promoting the dignified lives of its constituency by ensuring its people live in decent and safe conditions and that due process is observed at all times;


NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved by the 12<sup>th</sup> Sangguniang Bayan of Taytay, Rizal, in session duly assembled, to HUMBLY REQUEST THE LOCAL CHIEF

EXECUTIVE MAYOR ALLAN MARTINE S. DE LEON, MPA, TO CONDUCT AN INVESTIGATION AND TO CREATE A TASK FORCE TO TAKE APPROPRIATE ACTION ON THE GROWING NUMBER OF INFORMAL SETTLERS ALONG THE AREA OF THE LAGUNA LAKE IN THE MUNICIPALITY OF TAYTAY.


RESOLVED FURTHER, that a copy of this Resolution be furnished to the Office of the Municipal Mayor and all concerned for their information and appropriate action.
