WHEREAS, Sangguniang Kabataan Resolution No. 8, s. 2022, enacted by Sangguniang Kabataan of Barangay San Isidro in this Municipality has appropriated the amount of Five Million Two Hundred Ninety-Three Thousand Eight Hundred Ninety-Two Pesos and Five Centavos (Php 5,293,892.05) as its Annual Budget for FY 2023;

WHEREAS, the review of the Budget of the Sangguniang Kabataan of Barangay San Isidro was expressly lodged to the Sangguniang Bayan conformably with Section 314 of R.A. 7160;

WHEREAS, the Annual Budget of the Sangguniang Kabataan of Barangay San Isidro FY 2023 as submitted was initially reviewed and evaluated by the Municipal Budget Officer and has recommended that it be declared operative subject to conditions set forth in the review letter hereto attached;

WHEREAS, upon further review, the Budget of the Sangguniang Kabataan of Barangay San Isidro have complied with the budgetary requirements and general limitations provided in the Local Government Code; Budget does not exceed the estimated receipts or income of the Barangay; and the items of appropriation are not more than those provided by existing laws;


NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved by the 12<sup>th</sup> Sangguniang Bayan of Taytay, Rizal, in session duly assembled, hereby APPROVES IN REVIEW AND DECLARES THE ANNUAL BUDGET OF SANGGUNIANG KABATAAN OF BARANGAY SAN ISIDRO FY 2023 IN THE AMOUNT OF FIVE MILLION TWO HUNDRED NINETY-THREE THOUSAND EIGHT HUNDRED NINETY-TWO PESOS AND FIVE CENTAVOS (PHP 5,293,892.05) UNDER SANGGUNIANG KABATAAN RESOLUTION NO. 8, S. 2022, OPERATIVE SUBJECT TO CONDITIONS.

RESOLVED FURTHER, that the Sangguniang Kabataan of Barangay San Isidro shall strictly comply with the conditions set forth in the review and recommendation letter dated March 1, 2023 of the Municipal Budget Officer which shall form an integral part of this Resolution.


RESOLVED FINALLY, that copies of this Resolution be furnished to all concerned for their information and appropriate action.
