WHEREAS, pursuant to R.A. No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Bayan of Taytay as a Legislative Body of the Municipality is empowered to review the supplemental appropriation of barangays in the manner prescribed by law;

WHEREAS, Supplemental Budget No. 1 s. 2023 involving the amount of Three Hundred Seventy-Nine Thousand Five Hundred Thirty-Four Pesos and Two Centavos (Php 379,534.02) of Sangguniang Kabataan of Barangay Dolores was submitted to the Sangguniang Bayan for purposes of review;

WHEREAS, the source of funds for this supplemental budget of the Sangguniang Kabataan of Barangay Dolores is from the 2019 savings and 2022 proceeds of bidding documents amounting to Three Hundred Seventy-Nine Thousand Five Hundred Thirty-Four Pesos and Two Centavos (Php 379,534.02);

WHEREAS, the Committee on Finance, Budget and Appropriation after reviewing Supplemental Budget No. 1 s. 2023 of Sangguniang Kabataan of Barangay Dolores recommend that it be declared Operative subject to the conditions stated in its report;

WHEREAS, Supplemental Budget No. 1 s. 2023 of Sangguniang Kabataan of Barangay Dolores is in conformity with existing budgetary rules and regulations in accordance with the provisions of the Local Government Code of 1991 and there is no impediment for the immediate approval thereof;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved by the 12th Sangguniang Bayan of Taytay, Rizal, in session duly assembled, hereby APPROVES IN REVIEW AND DECLARES OPERATIVE, THE SUPPLEMENTAL BUDGET NO. 1 S. 2023 OF THE

SANGGUNIANG KABATAAN OF BARANGAY DOLORES, TAYTAY, RIZAL, APPROPRIATING THE AMOUNT OF THREE HUNDRED SEVENTY-NINE THOUSAND FIVE HUNDRED THIRTY-FOUR PESOS AND TWO CENTAVOS (PHP 379,534.02).

RESOLVED FURTHER, that copies of this Resolution be furnished to all concerned for their information and appropriate action.
