**A RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, ALLAN MARTINE S. DE LEON, MPA, TO REPRESENT AND SIGN FOR THE MUNICIPAL GOVERNMENT OF TAYTAY, PROVINCE OF RIZAL, THE MEMORANDUM OF AGREEMENT WITH THE BUREAU OF LOCAL GOVERNMENT FINANCE UNDER THE DEPARTMENT OF FINANCE FOR THE IMPLEMENTATION OF THE LOCAL GOVERNMENT REFORM PROGRAM PROJECT**

WHEREAS, Section 25, Article II of the 1987 Constitution enshrines that, “[t]he state shall ensure the autonomy of local governments”;

WHEREAS, Section 129 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991 provides that “[e]ach local government unit shall exercise its power to create its own sources of revenue and to levy taxes, fees, and charges subject to the provisions herein, consistent with the basic policy of local autonomy”;

WHEREAS, the Asian Development Bank (“ADB”) provided a Local Government Reform Project (“LGRP”) to the Government of the Philippines over a period of four (4) years from 2020 to 2024, to “help improve local government revenue mobilization, to build the capacity of local government units to deliver local public service and to strengthen their local governance performance”;

WHEREAS, the LGRP has “four (4) outputs: (i) institutional development and policy support for property valuation strengthened, (ii) property tax valuation database and information systems implemented, (iii) real property taxation of selected PROTOTYPE Local Government Units (“LGUs”) enhanced, and (iv) local assessors professionalized” and capacity of LGUs strengthened;

WHEREAS, the LGRP is projected to develop a Real Property Information System (“RPIS”); develop a Computer Aided Mass Appraisal system (“CAMA”) with Geographic Information System (“GIS”); establish an online transparency portal; develop, test and roll-out the RPIS in selected Prototype LGUs depending on the approved assigned system;

WHEREAS, the Bureau of Local Government Finance (“BLGF”) under the Department of Finance (“DOF”) has been designated as the executing agency of the LGRP, and further designated as among the implementing agencies of the project;

WHEREAS, the Municipality of Taytay complies with the general requirements of the LGRP, has adequate human and technical resources, is situated in a favorable environment, and firmly commits to participate and support the project, that will be implemented by the BLGF in the locality, particularly the participation in the Prototype LGU component of the LGRP;

WHEREAS, the participation in the LGRP will strengthen and improve the performance of the Municipal Government in the delivery of public service to its constituents;

WHEREAS, consistent with the goal of providing consistent, modern and constituent-centric *Serbisyong May Ngiti* to all Taytayeños, the signing of said Memorandum of Agreement is hereby necessary;


NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved by the 12<sup>th</sup> Sangguniang Bayan of Taytay, Rizal, in session duly assembled, to AUTHORIZE THE MUNICIPAL MAYOR, ALLAN MARTINE S. DE LEON, MPA, TO REPRESENT AND SIGN FOR THE MUNICIPAL GOVERNMENT OF TAYTAY, PROVINCE OF RIZAL, THE MEMORANDUM OF AGREEMENT WITH THE BUREAU OF LOCAL GOVERNMENT FINANCE UNDER THE DEPARTMENT OF FINANCE FOR THE IMPLEMENTATION OF THE LOCAL GOVERNMENT REFORM PROGRAM PROJECT.

RESOLVED FURTHER, that a copy of the signed Memorandum of Agreement be furnished to the Sangguniang Bayan for their information.


