WHEREAS, last December 19, 2022, the Sangguniang Bayan had approved and ratified the Annual Investment Program (AIP) CY 2023 of the Municipality of Taytay, Rizal through SB Resolution No. 139 series of 2022;

WHEREAS, there are inconsistencies found between the Annual Investment Program (AIP) CY 2023 and the Annual Budget CY 2023 for which adjustments are needed to be made;

WHEREAS, there is a need to amend the Annual Investment Program (AIP) CY 2023 to include an estimated fund amounting to One Billion Six Hundred Nineteen Million One Hundred Seventy Thousand Pesos (Php 1,619,170,000.00);

WHEREAS, submitted to the Honorable August Body is TDC Resolution No. 2023 - 003 for approval and ratification;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved by the 12th Sangguniang Bayan of Taytay, Rizal, in session duly assembled, to APPROVE AND RATIFY THE TAYTAY DEVELOPMENT COUNCIL (TDC) RESOLUTION NO. 2023 – 003 ENTITLED: "A RESOLUTION AMENDING (ADDENDUM) THE ANNUAL INVESTMENT PROGRAM (AIP) CY 2023 TO ADD THE AMOUNT OF ONE BILLION SIX HUNDRED NINETEEN MILLION ONE HUNDRED SEVENTY THOUSAND PESOS (PHP 1,619,170,000.00).
