WHEREAS, a fire broke out on April 8, 2023, at 9:43 p.m. on Rosario St., Brgy. San Juan, Taytay, Rizal, displacing 60 families or 116 individuals;

WHEREAS, the fire reached the third alarm at 10:02 p.m. and was declared fire out at 11:05 p.m.;

WHEREAS, Jelyn Sabaybay Gamas, 38, a resident of 68 Rosario St. for 18 years and the wife of Jayson Villanueva Gamas, showed remarkable heroism in rescuing her family and neighbors from the conflagration that cost her life and is one of the seven individuals who perished in the fire;

WHEREAS, it is proper that the Municipal Government of Taytay grant her a Plaque, in recognition of her exemplary courage and heroism on the fire incident at Rosario St., Brgy. San Juan, Taytay, Rizal last April 8, 2023;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved by the 12<sup>th</sup> Sangguniang Bayan of Taytay, Rizal, in session duly assembled, hereby HONORS JELYN SABAYBAY GAMAS (†) FOR HER EXEMPLARY COURAGE OF HEROISM ON THE FIRE INCIDENT AT ROSARIO ST., BRGY.
