YNARES TO ALLOCATE FUNDS FOR THE CONSTRUCTION OF A FOUR STOREY, 12 CLASSROOM BUILDING INSIDE THE CAMPUS OF ROSARIO OCAMPO ELEMENTARY SCHOOL THAT WILL SERVE AS THE INCLUSIVE LEARNING RESOURCE CENTER (CENTRAL SPED CENTER) FOR THE MUNICIPALITY OF TAYTAY, PROVINCE OF RIZAL.


