RESPONSIBILITIES OF THE E-SPORTS COORDINATOR OF THE
MUNICIPALITY OF TAYTAY**

WHEREAS, Republic Act 8044, also known as the Youth in Nation Building Act, states that the National Comprehensive and Coordinated Program on Youth Development shall be based on the following principles: Promotion and protection of the physical, moral, spiritual, intellectual and social well-being of the youth;

WHEREAS, the Philippine Youth Development Plan's youth agenda includes strengthening the enabling mechanisms for youth organizations and participation;

WHEREAS, the National Youth Commission issued YORP Advisory No. 04 series of 2023, inviting the Sangguniang Kabataan and its component Municipalities to enjoin the E-Palarong Pambansa to promote and encourage grassroots E-sports program nationwide among the Filipino youth;

WHEREAS, E-Palarong Pambansa will be handled by ILO Sports, a registered youth organization of the National Youth Commission - Youth Organization Accreditation Program;

WHEREAS, the E-Palarong Pambansa will be composed of 6 events: three (3) handheld games, two PC games and Web3 games;

WHEREAS, only one (1) E-sports Coordinator should be chosen to represent the Municipality to the E-Palarong Pambansa tournament;

WHEREAS, the following qualifications are needed for the position of E-Sports coordinator:

- Coordinator should be aged 18 to 60 years old.
- Must be a bonafide resident of this Municipality;
- Has knowledge and/or expertise of multiple e-sports games.
- Coaching or teaching experience preferred.
- Should not be playing professionally on E-sports league.
- Has a good moral character and not convicted of any crimes.
- Strong relationship-building skills.

- h. Ability to work with diverse community of players, organizers and professional colleagues.

WHEREAS, the E-sports Coordinator will have the following roles and responsibilities and will work in close coordination with the Municipal Sports Office:

- a. Be the contact person of ILO Sports regarding the Municipality’s E-Sports Team.
- b. Recruit and screen players for the E-sports team.
- c. Will report its progress and work to the Municipal Mayor’s Office through the Municipal Sports Office.
- d. Oversee all aspects of a comprehensive e-sports program for the team.
- e. Establish and maintain operating schedules for the team and ensure appropriate supervision levels for all operating hours and events.
- f. Manage game day preparation.
- g. Oversee and manage program budget in coordination and with the approval and supervision of the Municipal Sports Office.
- h. Submit a financial report to the Municipal Sports Office.
- i. Provide guidance and input on games on the selected team.
- j. Pursue sponsorship opportunities in coordination with the Municipality of Taytay.
- k. Ensure all persons and functions of the program exemplify the character and mission of this Municipality.

WHEREAS, selected applicants for the position of the E-sports Coordinator will be contacted for an interview with the Municipal Sports Office, SK Federation Office, Taytay Youth Development Office and a guest with knowledge and expertise in E-Sports;

WHEREAS, after the E-Sports Coordinator is selected, it will be responsible in creating the E-sports team in coordination with the Municipal Sports Office, SK Federation of Taytay and the Municipal Mayor’s Office;


WHEREAS, the Grand Finals for the E-Palarong Pambansa will be held on July 22-23, 2023;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved by the 12th Sangguniang Bayan of Taytay, Rizal, in session duly assembled, hereby SETS THE QUALIFICATIONS, ROLES AND RESPONSIBILITIES OF THE E-SPORTS COORDINATOR OF THE MUNICIPALITY OF TAYTAY.


RESOLVED FURTHER, that copies of this Resolution be furnished to all concerned for their information and appropriate action.
