A RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, ALLAN MARTINE S. DE LEON, MPA, TO SIGN AND ENTER INTO A MEMORANDUM OF AGREEMENT WITH COAST GUARD DISTRICT NATIONAL CAPITAL REGION - CENTRAL LUZON TO OPERATE ITS SUB-STATION IN THE MUNICIPALITY OF TAYTAY, AND FOR OTHER PURPOSES

WHEREAS, Section 5, Article II of the 1987 Constitution provides that, "[t]he maintenance of peace and order, the protection of life, liberty, and property, and the promotion of the general welfare are essential for the enjoyment by all the people of the blessings of democracy";

WHEREAS, Section 444(b)(1)(vi) of R.A. No. 7160, provides that the Municipal Mayor, upon authorization by the Sangguniang Bayan, may represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinance;

WHEREAS, the Municipality of Taytay is comprised of five (5) barangays, three (3) of which are coastal barangays while two (2) are located in the mainland;

WHEREAS, the Coast Guard District National Capital Region - Central Luzon is an armed and uniformed service tasked primarily with enforcing laws within Philippine waters, conducting maritime security operations, safeguarding life and property at sea, and protecting marine environment and resources;

WHEREAS, the Coast Guard District National Capital Region - Central Luzon recognizes the value of having the presence of the Municipal Government of Taytay in patrolling, enforcing the maritime law, and keeping the peace and order of the coastal area within its territorial jurisdiction;

WHEREAS, the Coast Guard District National Capital Region - Central Luzon seeks to coalesce and further enhance its partnership with the Municipal Government in pursuit of achieving bureaucratic efficiency, protecting the general welfare of communities and their inhabitants, as well as protecting and preserving the environment of the Municipality of Taytay;



WHEREAS, on 27 March 2023, the Coast Guard District National Capital Region - Central Luzon made representation with the Municipal Government requesting for a parcel of land or building to accommodate the Coast Guard Sub-Station Building and personnel such as but not limited to its Search and Rescue (SAR) Teams, Marine Environmental Protection Group (MEPG), Special Operations Units (SOU), K-9 Unit and other related safety and rescue gears under possession and supervision of the Coast Guard District National Capital Region - Central Luzon;

WHEREAS, the Municipal Government recognizes the urgent need of the Coast Guard District National Capital Region - Central Luzon to establish a veritable work zone to be able to effectively perform its maritime law enforcement duties, rescue missions, environmental protection protocols and the like;

WHEREAS, subsequent meetings were conducted by both parties which resulted in the grant of an office space for Coast Guard Sub-station Taytay measuring Thirty Square Meter (30 sqm) and Office Space for Marine Environmental Protection Group Rizal measuring Eighty-Six Square Meters (86 sqm) located at, B18, Pili St. Floodway Fishport, Sitio Lambak 1, Brgy. San Juan, Taytay, Rizal;

WHEREAS, based on these overriding considerations, the Municipal Government hereby allows the Coast Guard District National Capital Region - Central Luzon to occupy the abovespecified office space and recognized their occupancy, effective as of 27 June 2020 and extendable for a period prescribe by the Municipal Government depending on the availability of the area;

WHEREAS, consistent with the goal of providing Serbisyong May Ngiti to all Taytayeños, the signing of said Memorandum of Agreement is necessary;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved by the 12th Sangguniang Bayan of Taytay, Rizal, in session duly assembled, to AUTHORIZE THE MUNICIPAL MAYOR, ALLAN MARTINE S. DE LEON, MPA, TO SIGN AND ENTER INTO A MEMORANDUM OF AGREEMENT WITH COAST GUARD DISTRICT NATIONAL CAPITAL REGION -CENTRAL LUZON TO OPERATE ITS SUB-STATION IN THE MUNICIPALITY OF TAYTAY, AND FOR OTHER PURPOSES.

RESOLVED FURTHER, that the Memorandum of Agreement shall be ratified first by the 12th Sangguniang Bayan before its full implementation.

RESOLVED FURTHER, that a copy of this Resolution shall be forwarded to the Office of the Municipal Mayor, and all concerned offices in the Municipal Government of Taytay.
