WHEREAS, in providing utmost Serbisyong Nay Ngiti to all Taytayeños, the Municipal Government aims to strengthen social services available in the Municipality by providing Dialysis Treatment assistance to deserving indigent Taytayeños;

WHEREAS, Renal Med Dialysis Center, Inc. is a corporation established to provide dialysis treatment to its patients;

WHEREAS, Renal Med Dialysis Center, Inc., is willing to provide credit line for the Municipal Government by making its services available to qualified Taytayeño beneficiaries who are in dire need of the same, fostering and promoting the Municipal Government efficient delivery of social services:

WHEREAS, the Municipal Government signifies its willingness to shoulder the Co-pay Expenses incurred by qualified Taytayeño beneficiaries for a No Cash Out Policy; .

WHEREAS, the Memorandum of Agreement ("MOA") covers a unique circumstance of providing a credit line to the Municipal Government by Renal Med Dialysis Center, Inc. based on the number of clients served and services provided;

WHEREAS, consistent with the goal of providing *Serbisyong May Ngiti* to all Taytayeños, the signing of the MOA will provide much needed health services to indigent Taytayeños;



NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved by the 12<sup>th</sup> Sangguniang Bayan of Taytay, Rizal, in session duly assembled, to AUTHORIZE THE MUNICIPAL MAYOR ALLAN MARTINE S. DE LEON, MPA, TO NEGOTIATE AND ENTER INTO A MEMORANDUM OF AGREEMENT ("MOA") FOR THE MUNICIPAL GOVERNMENT OF TAYTAY, PROVINCE OF RIZAL, WITH RENAL MED DIALYSIS CENTER, INC. REPRESENTED BY ITS PRESIDENT, MARIA MARU A. BANAAG.
