## RESOLUTION NO. 218 series of 2023

A RESOLUTION APPROVING AND RATIFYING THE TAYTAY DEVELOPMENT COUNCIL (TDC) EXECUTIVE COMMITTEE RESOLUTION NO. 2023 – 001 ENTITLED: "A RESOLUTION AMENDING THE ANNUAL INVESTMENT PROGRAM (AIP) CY 2023", AMOUNTING TO FOUR HUNDRED TWENTY-FIVE MILLION PESOS (PHP 425,000,000.00)

WHEREAS, Section 16 of the General Welfare Clause of RA 7160 provides in part that every local government unit shall exercise powers necessary for its efficient and effective governance and those which are essential to the promotion of the general welfare;

WHEREAS, last December 19, 2022, the Sangguniang Bayan had approved and ratified the Annual Investment Program (AIP) CY 2023 of the Municipality of Taytay, Rizal through SB Resolution No. 139 series of 2022;

WHEREAS, one of the priority programs of our Municipality is the Municipal Social Fund (Cash Gift) Program for our Senior Citizens;

WHEREAS, aside from the Senior Citizens there are also plans that upon checking the current amount in the Annual Investment Plan (AIP), there is a need to increase the current amount to implement the said programs / plans;

WHEREAS, there is a need to amend the Annual Investment Program (AIP) CY 2023 to add the projects / programs amounting to Four Hundred Twenty-Five Million Pesos (Php 425,000,000.00), to wit:
