WHEREAS, Republic Act 10742 otherwise known as the “SK Reform Act of 2015”, ensures wide and multi-sectoral youth participation in governance, stating that a local youth development council shall be created to assist the planning and execution of projects and programs of the Sangguniang Kabataan (SK) and the federation in all levels;

WHEREAS, the SK Reform Act of 2015, requires the formulation of a 3-year Local Youth Development Plan (LYDP) which embodies developmental programs, projects and activities for the benefit of the youth organizations and youth-serving organizations embodied under the Sangguniang Kabataan;

WHEREAS, the Local Youth Development Plan (LYDP) shall be prepared in consultation with the Local Youth Development Council members, in accordance with Republic Act 10742 also known as the “SK Reform Law”;

WHEREAS, after thorough deliberation by the members of the Taytay Youth Development Council, the TYDC has adopted the Taytay Youth Development Plan (TYDP) 2023 – 2025 last May 12, 2023 and is respectfully being endorsed to the Sangguniang Bayan for its adoption and approval;

WHEREAS, the Taytay Youth Development Plan shall serve as the basis of the Sangguniang Kabataan in preparing their Comprehensive Barangay Youth Development Plan in their respective barangays;


NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved by the 12th Sangguniang Bayan of Taytay, Rizal, in session duly assembled, hereby ADOPTS AND APPROVES THE TAYTAY YOUTH DEVELOPMENT PLAN (TYDP) 2023 – 2025 OF THE MUNICIPALITY OF TAYTAY, PROVINCE OF RIZAL.

RESOLVED FURTHER, that the Taytay Youth Development Plan form part of this Resolution.
