WHEREAS, Section 16 of the General Welfare Clause of RA 7160 provides in part that every local government unit shall exercise powers necessary for its efficient and effective governance and those which are essential to the promotion of the general welfare;

WHEREAS, Section 447 paragraph 3(vi) and Section 458 paragraph 3(vi) of the Local Government Code of 1991 conferred unto the Municipal Government through the Sangguniang Bayan the power to regulate and grant franchise;

WHEREAS, the operation of tricycles is the primary mode of transportation in many areas in this municipality, servicing the secondary roads and subdivisions, and their operations greatly affect not only the mobility of the riding populace but also the peace, order, safety and harmony of the various area wherein these tricycles operate;

WHEREAS, the members of DSSNRTM TODA are requesting for Additional Fourteen (14) Lines (Franchise) to provide safe and efficient conveyance for commuters from Damayan Lumang Ilog, Barangay San Juan;


WHEREAS, the TMTFRB expressed no objection of this foregoing and have adopted TMTFRB Resolution No. 19 series of 2023 during their Board Regular Session held last May 11, 2023;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved by the 12th Sangguniang Bayan of Taytay, Rizal, in session duly assembled, hereby APPROVES AND RATIFIES THE TAYTAY MUNICIPAL TRICYCLE FRANCHISING AND REGULATORY BOARD RESOLUTION NO. 19 SERIES OF 2023 “APPROVING THE ADDITIONAL FOURTEEN (14) LINES (FRANCHISE) REQUEST FROM DAMAYAN SKWALA SUAREZ NAGTINIG ROADS TAYTAY MARKET DSSNRTM TODA FOR THE PURPOSE OF PROVIDING SAFE CONVEYANCE FOR COMMUTERS LOCATED AT DAMAYAN LUMANG ILOG, SAN JUAN, TAYTAY, RIZAL TO OPERATE WITHIN THE ROUTES AND TERMINAL ALLOCATED FOR THE TRICYCLE OPERATION”.
