- Executive Order No. 12 AN ORDER RE-ORGANIZING THE BARANGAY GENDER AND DEVELOPMENT FOCAL POINT SYSTEM (BGFPS) OF BARANGAY DOLORES, TAYTAY, RIZAL dated February 10, 2023.
- Executive Order No. 13 AN ORDER RE-ORGANIZING THE BARANGAY NUTRITION COUNCIL (BNC) OF BARANGAY DOLORES, TAYTAY, RIZAL dated February 23, 2023.
- Executive Order No. 14 AN ORDER RE-ORGANIZING THE OFFICE OF THE BARANGAY ANTI-VIOLENCE AGAINST WOMEN AND THEIR CHILDREN IN BARANGAY DOLORES, MUNICIPALITY OF TAYTAY, RIZAL DATED FEBRUARY 23, 2023.

- Ordinance No. 6 S. 2023 AN ORDINANCE ESTABLISHING AND INSTITUTIONALIZING DRUG FREE WORKPLACE POLICIES IN ALL GOVERNMENT OFFICES IN BARANGAY DOLORES, MUNICIPALITY OF TAYTAY, PROVINCE OF RIZAL INCLUDING THE CONDUCT OF AUTHORIZED DRUG TESTING FOR ELECTIVE AND APPOINTIVE PUBLIC / BARANGAY OFFICERS AND APPOINTIVE OF SERVICE PERSONNEL AND FOR OTHER PURPOSES.

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved by the 12<sup>th</sup> Sangguniang Bayan of Taytay, Rizal, in session duly assembled, hereby APPROVES IN REVIEW EXECUTIVE ORDER #11, EXECUTIVE ORDER #12, EXECUTIVE ORDER #13, EXECUTIVE ORDER #14, EXECUTIVE ORDER #15, EXECUTIVE ORDER #16 S. 2023 AND ORDINANCE NO. 6 S. 2023 OF BARANGAY DOLORES, PUNONG BARANGAY RUFE TAPAWAN.
