WHEREAS, the Local Chief Executive issued EO No. 38 series of 2022 creating the Technical Working Team (TWT) to study the establishment of the Taytay Municipal College under the Office of the Municipal Mayor;

WHEREAS, based on the Committee on Education hearing dated 15 June 2023, it was found out that the TWT was transferred under the supervision of the MPDO for their equipment, supplies and personnel while in the preparation phase of the establishment of the municipal college;

WHEREAS, the said transfer of jurisdiction from the OMM to the MPDO technically nullified Section 1 of EO 38 s. 2022 thus impeding the Interim Officers from carrying out their respective functions befittingly;


WHEREAS, issuing a new Executive Order placing the TWT-TMC under the MPDO will clothe the members with an official capacity to work on the processing of the requirements set forth by the Commission on Higher Education in establishing the Taytay Municipal College;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved by the 12<sup>th</sup> Sangguniang Bayan of Taytay, Rizal, in session duly assembled, hereby RESPECTFULLY REQUEST MAYOR ALLAN MARTINE S. DE LEON, MPA, TO ISSUE A NEW EXECUTIVE ORDER PERTAINING TO THE APPOINTMENT OF THE TECHNICAL WORKING TEAM FOR THE ESTABLISHMENT OF THE TAYTAY MUNICIPAL COLLEGE UNDER THE MUNICIPAL PLANNING & DEVELOPMENT OFFICE (MPDO).
