WHEREAS, the Municipality of Taytay has been home to many Muslim Filipinos since the early 1990s and is now composed of members from the five Muslim Tribes namely; Muranao, Maguindanao, Tausog, Calagan, and Balik Islam;

WHEREAS, the members of the Islam religion have certain beliefs and practices that would require the special considerations and assistance from the Local Government of Taytay;

WHEREAS, Engr. Rahmatol M. Mamukid, Regional Director of the South Luzon Regional Office of the National Commission on Muslim Filipinos, has already proposed through a communication sent to the Local Chief Executive, the creation of the council;

WHEREAS, the council shall be the advisory board of the Mayor in terms of suggesting policies and programs concerning the Muslim population and in dealing with any concerns involving the members of the Islam Community;

WHEREAS, the council could be composed of representatives from the five (5) Muslim tribes present in the municipality and an overall convener voted upon by these representatives;


WHEREAS, the establishment of a Muslim Consultative Council may help bridge indifferences between religions, forge meaningful collaborations, and erase stigma among the residents of the municipality;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved by the 12th Sangguniang Bayan of Taytay, Rizal, in session duly assembled, hereby HUMBLY REQUESTS THE LOCAL CHIEF EXECUTIVE MAYOR ALLAN MARTINE S. DE LEON, MPA TO ISSUE AN EXECUTIVE ORDER FORMING THE TAYTAY MUSLIM CONSULTATIVE COUNCIL.


RESOLVED FURTHER, that copies of this Resolution be furnished and forwarded to all parties concerned.
