A RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, ALLAN MARTINE S. DE LEON, MPA, TO REPRESENT AND SIGN FOR THE MUNICIPAL GOVERNMENT OF TAYTAY, PROVINCE OF RIZAL, A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS - RIZAL 1ST DISTRICT ENGINEERING OFFICE FOR THE CONSTRUCTION AND REHABILITATION OF VARIOUS WATER SUPPLY, SEPTAGE, SEWERAGE, RAIN WATER COLLECTORS, AND SOLAR WATER SYSTEM IN THE MUNICIPALITY OF TAYTAY, PROVINCE OF RIZAL, AND FOR OTHER PURPOSES

WHEREAS, Section 5, Article II of the 1987 Constitution provides that “[t]he maintenance of peace and order, the protection of life, liberty, and property, and the promotion of the general welfare are essential for the enjoyment by all the people of the blessings of democracy”;

WHEREAS, Section 3 of the Office of the President Executive Order No. 124, Series of 1987, provides that, “[t]he planning, design, construction and maintenance of infrastructure facilities, especially national highways, flood control and water resource development systems, and other public works in accordance with national development objectives, shall be the responsibility of such an engineering and construction arm.” which is the Department of Public Works and Highways (“DPWH”);

WHEREAS, Section 16 of Republic Act (“R.A.”) No. 7160 otherwise known as the Local Government Code states that, “[e]very local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare”;

WHEREAS, Section 25(b) of R.A. No. 7160 otherwise known as the Local Government Code states that, “[n]ational agencies and offices with project implementation functions shall coordinate with one another and with the local government units concerned in the discharge of

these functions. They shall ensure the participation of local government units both in the planning and implementation of said national projects”;

WHEREAS, Section 444(b)(1)(vi) of R.A. No. 7160 provides that the Municipal Mayor, upon authorization by the Sangguniang Bayan, may represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinance;


WHEREAS, consistent with the goal of providing *Serbisyong May Ngiti* to all Taytayeños, the signing of said Memorandum of Agreement is hereby necessary;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved by the 12th Sangguniang Bayan of Taytay, Rizal, in session duly assembled, to AUTHORIZE THE MUNICIPAL MAYOR, ALLAN MARTINE S. DE LEON, MPA, TO REPRESENT AND SIGN FOR THE MUNICIPAL GOVERNMENT OF TAYTAY, PROVINCE OF RIZAL, A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS - RIZAL 1ST DISTRICT ENGINEERING OFFICE FOR THE CONSTRUCTION AND REHABILITATION OF VARIOUS WATER SUPPLY, SEPTAGE, SEWERAGE, RAIN WATER COLLECTORS, AND SOLAR WATER SYSTEM IN THE MUNICIPALITY OF TAYTAY, PROVINCE OF RIZAL, AND FOR OTHER PURPOSES.


