WHEREAS, the road lots located at Philippians Subdivision, Bangiad, Barangay San Juan, this municipality is owned and registered under the name of Ms. Marilou C. Fernandez and the heirs of Virgilio G. Tamayo Jr.;

WHEREAS, the owners have executed a Deed of Donation involving the said property which is particularly covered by TCT No. 594362 with an area of 5,080 square meters and TCT No. 623233 and with an area of 842 square meters;

WHEREAS, the donation of road lots of the subject property to the municipality shall further develop the property which will benefit the residents therein;

WHEREAS, the Sangguniang Bayan finds the intention beneficial to the community and worth considering;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved by the 12th Sangguniang Bayan of Taytay, Rizal, in session duly assembled, hereby AUTHORIZES THE MUNICIPAL MAYOR, HON. ALLAN MARTINE S.
