WHEREAS, Section 11, Article XIII of the 1987 Constitution provides that, “[t]he State shall adopt an integrated and comprehensive approach to health development which shall endeavor to make essential goods, health and other social services available to all the people at affordable cost. There shall be priority for the needs of the underprivileged sick, elderly, disabled, women, and children”;

WHEREAS, Section 17(b)(2)(iv) of R. A. No. 7160 provides that Local Governments shall provide social services through projects and programs for the welfare of the elderly and persons with disabilities;

WHEREAS, the Sangguniang Bayan of the Municipality of Taytay passed Ordinance No. 740, Series of 2022 also known as the Taytay Senior Citizen Cash Gift Ordinance of 2022 “to ensure the elderly citizens in the municipality to be happy and enjoy a decent quality of life such as emotional well-being, close interpersonal relationships with family members and friends even in their twilight years”;

WHEREAS, in compliance with Ordinance No. 740, the unreleased Senior Cash Gift amounting to Two Thousand Pesos (Php 2,000.00) shall be released in favor of Taytayeño Senior Citizens with surnames starting from Letters N to Z, outside of the Social Pension from the Department of Social Welfare and Development;

WHEREAS, Section 7 of Sangguniang Bayan Ordinance No. 783 amending Ordinance No. 740 provides that “[a]ll qualified Senior Citizens of the Municipality shall receive an amount of Php 2,500.00 annually”;

WHEREAS, consistent with the goal of providing *Serbisyong May Ngiti*, the immediate release of the Senior Cash Gift in favor of Taytayeño Senior Citizens excluded from the National Social Pension from the Department of Social Welfare and Development is imperative;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 12th Sangguniang Bayan of Taytay, Rizal, in session duly assembled, hereby EXPRESSES SUPPORT FOR THE FULL IMPLEMENTATION TO RELEASE SENIOR CASH GIFT FOR THE TAYTAYEÑO SENIOR CITIZENS.

RESOLVED FURTHER, that a copy of this Resolution shall be forwarded to the Office of the Municipal Mayor, and all concerned offices in the Municipal Government of Taytay
