WHEREAS, Section 16 of Republic Act ("R.A.") No. 7160, otherwise known as the Local Government Code states that, "[e]very local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare";

WHEREAS, Section 444(b)(1)(vi) of Republic Act ("R.A.") No. 7160, otherwise known as the Local Government Code of 1991 provides that the Municipal Mayor, "[u]pon authorization by the Sangguniang Bayan, may represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinance";

WHEREAS, the constructed pedestrian overpasses / footbridges in the municipality needs maintenance and repainting due to its age and everyday usage particularly the following overpasses:

- Taytay - Tikling Junction, Ortigas Ave. Extension connecting to Taytay Diversion Road
- Taytay Diversion Road near East Acropolis
- ROES Footbridge
- Taytay - Near Tiangge

WHEREAS, Davies Paints Philippines, Inc. has been a partner of the Municipal Government since before year 2022, in the construction and beautification of infrastructures for the benefit of its constituents;

WHEREAS, Davies Paints Philippines, Inc. offered to partner and cooperate with the Municipal Government of Taytay to repaint select pedestrian overpass in the Municipality that needs maintenance and repainting, through a Memorandum of Agreement;


WHEREAS, consistent with the goal of providing *Serbisyong May Ngiti* to all Taytayeños, the signing of said Memorandum of Agreement is hereby necessary;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 12<sup>th</sup> Sangguniang Bayan of Taytay, Rizal, in session duly assembled, to AUTHORIZE THE MUNICIPAL MAYOR, ALLAN MARTINE S.
