WHEREAS, Section 3, Article XIV of the 1987 Constitution states that the State shall mandate all educational institutions to develop awareness, foster love of humanity, strengthen ethical values and develop moral character and personal discipline;

WHEREAS, Section 3 of Republic Act No. 10627 known as the "Anti-Bullying Act of 2013" states that "All elementary and secondary schools are hereby directed to adopt policies to address the existence of bullying in their respective institutions";

WHEREAS, the Department of Education (DepEd) maintains that schools shall include in its training programs courses or activities which shall provide opportunities for school administrators, teachers and other employees to develop their knowledge and skills in preventing or responding to any bullying act;

WHEREAS, Rule IV of Department Order 55 s. 2013, underscores that the bullying prevention program in schools shall be comprehensive and multifaceted, and shall involve all education stakeholders and personnel;

WHEREAS, having the Anti-Bullying Policy being observed by the school administration posted in plain view inside the campus shall be a form of a declaration that there are measures being observed geared towards prevention of bullying inside their respective schools and it shall likewise serve as an assurance to students, school personnel and parents that anti-bullying is being taken seriously by all stakeholders;
