A RESOLUTION ACKNOWLEDGING THE PUBLISHED MATERIALS, BOOKS, PROMULGATIONS AND COMPILATIONS THAT MENTIONED "TAYTAY" AS PART OF THE OFFICIAL ARCHIVES OF THE MUNICIPALITY OF TAYTAY, RIZAL

WHEREAS, per Proclamation 339 series of 2012, the month of August every year was declared as the celebration of History Month aiming to emphasize significant turning points in the Philippine History;

WHEREAS, as of the moment, the official foundation and pre-colonial history of Taytay has yet to be set in stone and the Sangguniang Bayan finds it timely to start the deliberation in the municipal level for possible legislation of the said intention beneficial to Taytayeños and community's roots and identity;

WHEREAS, sometime in the year 2016, the 10th Sangguniang Bayan of Taytay under the Committee on Tourism and Special Events chaired by Councilor Philip Jeison J. Cruz and its members by then Councilor Sophia Priscilla L. Cabral, Councilor Archie L. Calderon, Councilor Sharon DL. Macabebe and Councilor Jan Victor B. Cabitac had initially accepted the compiled materials gathered in coordination with the Sangguniang Bayan Secretariat Team, from then on they visited several offices and libraries to conduct interviews and solicit information from municipal, provincial, national government institutions, state universities and other private related offices;

WHEREAS, based on the research conducted, the Team found the oldest compilation by Father Felix de Huerta published in 1855 entitled **Estado Geografico**, **Topografico**, **Estadistico**, **Histórico-Religioso De La Santa Y Apostolica Provincia** and that page 53 mentions the name Taytay as one of the communities in the Namayan Territory way back 1579; likewise, the historic conversion of the town was also mentioned on page 572 of the same book;

WHEREAS, on page 132 to 134 of **Tanay Tercentenary Souvenir** book, 1640-1940: The Towns of Rizal Province, Taytay was mentioned beginning from the year 1571 up to 1939;

WHEREAS, Act No. 984 of 1903, Section 1(a) states that the municipality of Taytay shall consist of its present territory and that of the municipality of Cainta, with the seat of the municipal government at the present municipality of Taytay;

WHEREAS, the book **The Rizal Province**; **A Political History** by Cesar S. Tiangco, Rizal Cultural Committee, Office of the Government of Rizal, mentions Taytay in the following pages:

- On page 7, it was mentioned that Taytay is one of the thickly populated communities during the year 1571.
- On page 27 to 28, Loarca's Relacion de las Yslas Filipinas mentions several encomiendas in the Rizal area as existing as early as 1582, one of which was Taytay with five hundred (500) Indians. It was also mentioned that the encomienda belonged to Juan Pacheco with six hundred (600) tributes under the instruction of the Franciscans.
- On page 41, a brief history of Taytay was shown, which was also gathered from the Tanay Tercentenary book.
- On page 41 to 42, Based on Buzeta's Geografico, Estadistico, Historico de las Islas Filipinas, printed in 1850, Taytay was one of the Manila towns administered by Tondo. It was also mentioned that Taytay was part of the politico-military district.
- On page 49, it was said that in 1858, the whole of Morong Politico-military District, where Taytay was a part of, was judicially placed under the Alcalde Segundo of Manila and the Alcalde Mayor Tercera, but was later changed when the Morong District had its own court in 1894.
- On page 51, it was mentioned that the Administracion de Pasig was created on September 14, 1850, encompassing cities including Taytay.
- On page 217, written at the bottom part of the page was the Municipal Reorganization under Governor Flores which was dated on December 31, 1901. It is said that he organized twenty-nine municipalities (29) and added four (4) organized communities under General Order 40. One of the four added municipalities was Taytay in 4th class with a population of 6,172.
- It was also mentioned on page 223 the Executive Orders or Acts which affected the Municipalities, including the municipality of Taytay, and the date of start as Independent Municipality.

WHEREAS, The Rizal Province Directory (Volume 1), History, Government and General Information, with the Full Text of the Philippine Independence Law, Edited and Compiled by Isayas R. Salonga 1934, mentioned Taytay on the following pages:

- On page 9-10, the Historical Sketch of Rizal Province was shown, narrating the history of Rizal and how it was created. It said that in 1925, by virtue of an Order from the Department of Interior, the province of Rizal was made a firs class province. There were 27 municipalities classified, one of which was Taytay who was classified as Third Class.
- On page 15, it was mentioned that Taytay is known for furniture making, alongside Caloocan and Malabon.
- On page 40, The Statistics on Deaths, Births, and Marriage in the year 1993 of Taytay was shown.
- On page 151 to 154, a brief history of Taytay and its territory was written.
- On page 197, the list of Municipal Officials-Elect for 1934-1937 and other officers of Taytay was presented.

WHEREAS, Taytay was also mentioned in the National Historical Commission of the Philippines Resolution No. 01, S. 2014, which states that: "the Santa Ana area's established role as an administration center was affirmed by the foundation of Santa Ana de Sapa, the very first mission established by the Franciscans outside of Intramuros that was used as a base for evangelizing operations and later became the mother parish of congregations in places like Makati, Quiapo, and Taytay in present day Rizal province";

RESOLVED FURTHER, that a thorough validation of the aforementioned data and materials be conducted by concerned sections and departments of the Local Government Unit of Taytay to further recognize the basis towards the declaration and legislation of important dates for the Municipality of Taytay, Rizal.
