NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 12th Sangguniang Bayan of Taytay, Rizal, in session duly assembled, hereby AUTHORIZES THE MUNICIPAL MAYOR, ALLAN MARTINE S. DE LEON, MPA, TO SIGN AND ENTER INTO A MEMORANDUM OF AGREEMENT WITH PHILIPPINE VETERANS BANK REPRESENTED BY ITS BRANCH MANAGER MS. ALMA B. VALDEZ, FOR THE SALARY LOAN PROGRAM.

RESOLVED FURTHER, the duly signed MOA between PVB and the Municipal Government shall be ratified first by the Sangguniang Bayan before its full implementation.
