WHEREAS, pursuant to R.A. No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Bayan of Taytay as a Legislative body of the Municipality is empowered to review the supplemental appropriation of barangays in the manner prescribed by law;

WHEREAS, Supplemental Budget No. 1 involving the amount of Seven Million Three Hundred Forty-Seven Thousand Eight Hundred Thirty-Six Pesos and Fifty-One Centavos (Php 7,347,836.51) of Barangay Dolores under Sangguniang Barangay Appropriation Ordinance No. 7 series of 2023 was submitted to the Sangguniang Bayan for purposes of review;

WHEREAS, the source of funds for this supplemental budget of Barangay Dolores is from General Fund;

WHEREAS, the Committee on Finance, Budget and Appropriation after reviewing Supplemental Budget No. 1 series of 2023 of Barangay Dolores recommends that it be declared Operative subject to the conditions stated in its report;

WHEREAS, Supplemental Budget No. 1 series of 2023 of Barangay Dolores is in conformity with existing budgetary rules and regulations in accordance with the provisions of the Local Government Code of 1991 and there is no impediment for the immediate approval thereof;


NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 12th Sangguniang Bayan of Taytay, Rizal, in session duly assembled, to APPROVE IN REVIEW AND DECLARE OPERATIVE, THE SUPPLEMENTAL BUDGET NO. 1 SERIES OF 2023 INVOLVING THE AMOUNT OF SEVEN MILLION THREE HUNDRED FORTY-SEVEN THOUSAND EIGHT

HUNDRED THIRTY-SIX PESOS AND FIFTY-ONE CENTAVOS (PHP 7,347,836.51) OF BARANGAY DOLORES UNDER SANGGUNIANG BARANGAY APPROPRIATION ORDINANCE NO. 7 SERIES OF 2023.
