WHEREAS, pursuant to R.A. No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Bayan of Taytay as a Legislative body of the Municipality is empowered to review the supplemental appropriation of barangays in the manner prescribed by law;

WHEREAS, Supplemental Budget No. 2 involving the amount of Six Hundred Fifteen Thousand Four Hundred Thirty-One Pesos and Forty-Four Centavos (Php 615,431.44) of Sangguniang Kabataan of Barangay Dolores was submitted to the Sangguniang Bayan for purposes of review;

WHEREAS, the source of funds for this supplemental budget of Sangguniang Kabataan of Barangay Dolores is from General Fund;

WHEREAS, the Committee on Finance, Budget and Appropriation after reviewing Supplemental Budget No. 2 of Sangguniang Kabataan of Barangay Dolores recommends that it be declared Operative subject to the conditions stated in its report;

WHEREAS, Supplemental Budget No. 2 of Sangguniang Kabataan of Barangay Dolores is in conformity with existing budgetary rules and regulations in accordance with the provisions of the Local Government Code of 1991 and there is no impediment for the immediate approval thereof;




RESOLVED FURTHER, that copies of this Resolution be furnished to all concerned for their information and appropriate action.
